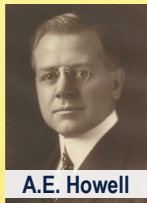
KEEPING OUR SCHOOLS SAFE

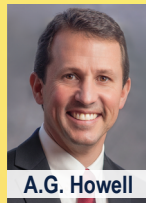
